BOARD MEETING MINUTES

1. OPENING

The November 8, 2016 meeting of the Board of Trustees of the Southwest Licking Community Water and Sewer District was called to order by Mr. Kretzmann at 1:00 pm. Resolution to Reduce Deferred Assessment: Mr. Conkel presented Resolution No. 2016-053 to approve the reduction of a deferred sanitary sewer assessment on parcel #25-067806-00.000 due to 2.046 acres being split and the assessment being paid in full. Mr. Kretzmann made a Motion to approve Resolution No. 2016-053 and Mr. Meade seconded. Upon roll call vote, all voted aye. Resolution No. 2016-053 was approved.

B. Potential Well Field: Mr. Conkel stated that he will be speaking with an owner of property in the east Licking County area which may provide a good source of water.

C. Watkins Grove: Mr. Conkel reported that the Watkins Grove Phase II development, with 45 lots, will soon be submitting a developer's agreement so that the second phase of the development can move forward.

D. Cost Less Lighting: Mr. Conkel indicated that the District has received plans for the Cost Less Lighting facility which is scheduled to be built in 2017 in the spring.

12. TRUSTEE COMMENTS

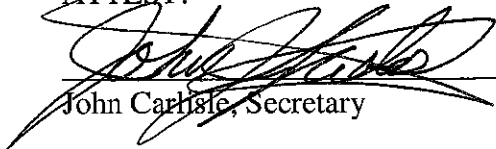
