## 7. GENERAL MANAGER'S REPORT

- a. Presented Resolution 2016-008 to purchase a 2016 F-250 extended cab truck for the collections department. Heavy duty truck needed as it hauls generators and heavier tools. Mr. Rector reported he compared with State Bids and this is a good deal. Motion by Mr. Carlisle, seconded by Mr. Kretzmann to pass Resolution 2016-008. Upon roll call, all voted aye.
- b. Presented the December 2015 vehicle mileage and fuel report to the board for review.
- c. Presented the Office Report. Tap fees are at approximately \$52,000 so far this year. Mr. Carlisle stated that new development of approximately 60 homes in the Watkins Grove, Phase 2 and 3 is a go. Discussion on the two developers.
