SUMMIT/CABLE WATER LINE MEETING:

Mr. Conkel stated the public meeting was held last Thursday, September 7, 2017 at 7:00-p.m. He stated that it wasn't as well-received as he had thought it would be. He stated that there were a lot of residents at the meeting that thought the District would force them to hook up to the water service. Mr. Conkel stated that he discussed potential voluntary assessments with Mr. John Albers as an option for residents wishing to connect to the District's water service. The Board was in favor of allowing a voluntary assessment to be used for the tap fee.

WATER TREATMENT PLANT CONCENTRATE LINE:

Mr. Conkel stated that he is putting out an RFQ for engineers to design the Water Treatment Plant Concentrate Line.
